



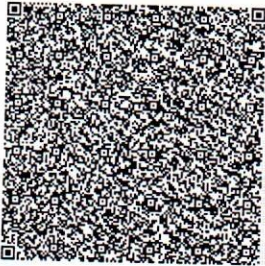


#### Affidavit

I, the above named deponent, do hereby solemnly affirm and declare as under:


1. That the deponent is fully conversant with the functioning of the company and competent to depose this affidavit.

2. That the establishment of the deponent viz. **Orion Security Solution Pvt Ltd.** (hereinafter referred to as the contractor) is an independent legal identity and contractor in accordance with the provisions of the Contract Labour (Regulation & Abolition) Act, 1970, having its employees deployed/shall deploy 50 numbers of employees at the premises of **M/s. The Press Trust of India Limited.** (hereinafter referred to as the Principal Employer) to carryout Assembly / Loading / Unloading and packing etc, provided at **M/s. The Press Trust of India Limited** That the deponent has entered into an agreement with **M/s. The Press Trust of India Limited** ,Parliament street, New Delhi-110001carryout above work which shall remain in force **from 01 JAN 2018 to 31 DEC 2018.**
3. That the Principal Employer does not have any employee on its own Muster Rolls doing the same nature of work, which is being/shall be done by the employees of the Deponent's establishment deployed/to be deployed at the premises of the Principal employer.
4. That those workers employed/shall be employed by the deponent contractor and performing the same & similar kind of work as the worker/s directly employed by the Principal Employer are being/shall be paid the same wages as applicable to the directly employed worker/s.
5. That each and every employee of the establishment of the deponent contractor is being/shall be paid not less than the minimum rates of wages fixed for their category of employment under the provisions of Minimum Wages Act, 1948.
6. That the establishment of the deponent contractor is/shall be providing all statutory benefits and maintaining the records under the applicable Labour Laws in respect of all the worker/s deployed/shall be deployed at the premises of the principal employer.
7. That the process (es)/work/job(s) on which the contract workers are to be deployed is/are not abolished by any authority or board.
